4. The following test are to be conducted -  
(a) Running - 1.5 KM within 6 min.  
(b) Carrying 50 Kg to a distance of 200 meter in 100 Seconds.  
(c) Women Test

5. Selection will be made as per existing rules and regulation in the department.  
6. Post mentioned above are subject to all India Transferability and field service medical Rules.

7. Candidate will forward application in a properly sealed envelope to the address mentioned above through ordinary post. Candidates are requested to superscribe the words "APPLICATION FOR THE POST OF \_\_\_\_\_" on the top of the envelope while sending the application form. Separate application is required for each post.

8. Last date for receipt of application is 21 days from the date of publication of the advertisement.

9. The crucial date for determining the age limit shall be closing date for receipt of application.

10. All test will be held on screening basis i.e. the candidate has to pass in the first test in order to be eligible for the second test and so on.

11. Candidate fulfilling the above conditions may submit application as per format given below and attach photocopy of the following documents/certificate duly attested by a Gazetted Officer.

- Attested copy of Matriculation Certificate.
- Attested Birth Certificate or equivalent.
- Last medical fitness certificate issued by approved Central/State Govt hospital giving measurement of height, chest & weight.
- Current Employment Exchange Register Card if held.
- SC/ST (Non-creamy layer) certificate if applicable.
- Character certificate by police/school/college with validity of 06 months from the date of issue.
- NOC in original from their present employer in case of Government servant.
- Experience Certificate if any.
- One additional attested photograph.
- Any other documents in support of information furnished in application.
- One 12 x 18 cms self-addressed envelopes of good quality affixed with Rs. 25.00 postage stamp would be attached alongwith the application form.

Note :- Original certificate should not be sent with the application. These should be produced only at the time of test.

12. Incomplete/illegible application will be deemed invalid and rejected without intimation to the candidate. Only eligible candidate will be called for the written examination provided a self-addressed envelope with postal stamp of Rs. 25/- is enclosed with the application form.

13. Merely fulfilling the basic selection criteria does not automatically entitle a person to be called for test.

14. Application will be short listed on the basis of percentage of marks obtained in the examination for essential qualification.

15. No extra weightage will be given for additional/higher qualification.

16. The number of vacancies, reservation is subject to change. Further the employer has the right to cancel or modify this notification without assigning any reason thereof.

17. Canvassing in any form shall disqualify the candidate. No enquiry or correspondence will be entertained.

18. No TA/DA is admissible. Duration of the test can be 02 or 03 days or more. Candidate will make their own arrangement for lodging/boarding during the test.

19. The decision of appointing authority regarding selection/rejection will be final.

20. The recruitment process can be cancelled/postponed/suspended/terminated without any prior notice/assigning any reasons at any stage.

21. Test will be held at Supply Depot Lansdowne. Applicant should report one hour before at Supply Depot ASC, Lansdowne, Pin- 900400 on date and time as mentioned in the ADMIT CARD. No separate letter will be issued.

22. Candidate will be in possession of their ADMIT CARD at the all time and produce original documents on physical arrival otherwise they will not be allowed to appear for tests.

23. Disqualification:- The following acts/omission would render a candidate/ application disqualified :-

- Furnished of false, inaccurate or tampered information or documents.
- Obtained support for his candidature by any means.
- Improper filling of application.
- Impersonation by any person.
- Submitted more than one application by same applicant.
- Any other reason as observed by the Board of Officers.
- Candidate selected will be on probation for a period of two years. This unit reserves the right to terminate the appointment during the period of probation without assigning any reasons.

- General Intelligence and Reasoning** : The question will be non-verbal type. The test may include question on analogies, similarities, and different space visualization problems solving, analysis, judgment, decision making, visual memory discrimination, observation, relationship concept, figure classification, Arithmetical, number series, non-verbal series, abilities to deal with abstract ideas and symbols and their relationship, arithmetical computation and other analytical functions.
- The question will be designed to test the ability of candidate general awareness of the environment around him/her its application to society, current events and of such matter of everyday observation and experience in their scientific aspects, relating to India and its neighboring countries especially pertaining to Sports, History, Geography, Economics, Science, General Polity including Indian Constitution and Scientific Research etc.
- Numerical Aptitude** : Problem relating to Number System of Whole Numbers, Decimal and Fractions and relationship between Fundamental Arithmetical Operations, Percentage, Graphs, Mensuration, Time and Distance, Ratio and Time, Time and work etc.
- General English** : Basic of English Language its vocabulary, Grammar, sentence structure, synonym, Antonyms and its correct usage, etc., writing ability would be tested.
